CLUB WILD RULES OF PARTICIPATION

1. All individuals must be twenty-one (21) years of age or older to qualify for membership in Club Wild program.
2. Individuals may sign up at the Club Wild booth at Wildwood Hotel & Casino.
3. Valid, unexpired photo identification is required for membership registration, activation, point redemptions and for obtaining any information with respect to a Club Wild account.
4. Acceptable forms of photo identification are as follows: State issued Driver's License, State issued ID card, Government issued passport, Military ID, or a Government issued Green Card.
5. The benefits of the program are solely intended for the use of the person listed on the account.
6. Individuals may not create an account on behalf of another person or create an account using another person's identity or information, regardless of written approval, familial or relationship status.
7. Members may only hold one Club Wild membership at any given time. The Club Wild account number associated with the cardholder is intended for the use of the cardholder only.
8. Club Wild members will be responsible for selecting a confidential PIN for their account and for keeping their PIN secure. Each member is responsible for all transactions on the account when the PIN is used.
9. Club Wild membership cards, points, offers, awards, and all other program benefits are non-transferrable.
10. Any misuse of a Club Wild account or improper play will subject the unauthorized user to forfeiture of cardholder privileges, criminal or civil penalties, or both.
11. Club Wild account discrepancies should be immediately reported to Wildwood Hotel & Casino to be eligible for reconsideration.
12. Club Wild members should notify Wildwood Hotel & Casino of any name, address, email, or phone number change to continue to receive information on the Club Wild program, offers, bonuses, invitations, or other events.
13. In the event of the death of a Club Wild member, the member's redeemable points will be held pending disposition under the laws of descent and distribution and all existing benefits will be cancelled.
14. Wildwood Hotel & Casino reserves the right to deny an application to the Club Wild program or revoke a Club Wild membership at any time in its sole discretion.
15. Participation in the Club Wild program constitutes each member's agreement to abide by the rules of this program.
16. Wildwood Hotel & Casino is not responsible for lost or stolen Club Wild cards.
17. All applicable taxes relating to a Club Wild member receiving awards is the sole responsibility of the member.
18. Any Club Wild card that has been mutilated, forged, altered, tampered with, mechanically reproduced, is illegible, or has been obtained by any means other than pursuant to these Official Rules is automatically void. Wildwood Hotel & Casino reserves the right to void any Club Wild card, voucher, or offer at its sole discretion.
19. Any rule or procedure relating to the Club Wild program may be changed, modified, or cancelled by Wildwood Hotel & Casino at any time and in its sole discretion without prior notification.
